**DISCUSSION**

**FY2021/2022 Capital Improvement Budget**

City Administrator McConachie provided an overview of the current Fiscal Year 2020/2021 Capital Improvement Budget.

Proposed Expenses for FY2020/2021 include:

- Equipment: \$189,000
  - Replacement Computers: \$15,000
  - Server: \$15,000
  - Network Switches: \$7,000
  - 1 Ton Dump Truck: \$55,000
  - Skidsteer Side Dump Bucket: \$8,000
  - Patrol Vehicles (2): \$80,000
  - Taser (6): \$9,000
- Projects: \$220,000
  - Streetlights: \$150,000
  - Containment Area Improvement (adjacent to Legion Park): \$30,000
  - Garage Lot Improvements: \$40,000
- Street work:
  - Overlays: \$112,500
  - NovaChip (Woodson Road): \$420,000
  - Concrete: \$30,765
  - Preventative Maintenance: \$15,000
  - Miscellaneous Repairs: \$50,000
  - Sidewalks: \$30,000

**FY2020/2021 Parks Budget – Capital Equipment/Projects**

City Administrator Jason McConachie reviewed the FY2020/2021 Parks Budget. These are items that have been proposed to be added back to the current year budget.

- Community Center Marquee Sign Replacement – Budget estimate: \$47,000
- Remove Community Center Whirlpool – Budget estimate: \$10,000

- Repainting Community Center Gymnasium – Budget estimate: \$58,000
- Tree Removal & Trimming – Budget estimate: \$60,000
- Replace Roof of Garage in Wild Acres Park – Budget estimate: \$15,000

Councilman Fetsch made a motion to move forward with staff recommendation for amending the budget for FY2020/2021 Park Fund. Councilwoman Ridolfi seconded. The vote was recorded as follows: Little – yes; Wroblewski – yes; Fetsch – yes; Ridolfi – yes; Owensby – no; Jones – yes; Thomas – yes; and Palakarn – yes. Motion carried.

Staff will prepare legislation to amend the FY2020/2021 Park Fund Budget for Council action at the February 22, 2021 Council Meeting.

**FY2021/2022 Parks Fund Budget – Initial Review**

City Administrator McConachie reviewed Parks Fund projected revenue for FY2021/2022 is \$1,000,000. Approximately \$808,000 per fiscal year are operating expenses.

Requests Not Recommended for Approval: \$166,000

- Community Center Paging/Intercom System: \$20,000
- Utility Vehicle: \$25,000
- Exposed Ceiling Cleaning: \$46,000
- Mort Jacobs Park Restroom Renovation: \$75,000

Proposed Projects for FY2020/2021: \$190,000 total

- Resurface Gym floors: \$60,000
- Replacement of Fitness/Track Flooring: \$40,000
- Resurface Tennis Courts at Woodson Road Park: \$40,000
- Municipal Park Grant Project: \$50,000

Discussion took place to add the Mort Jacobs Park Restroom Renovation to the projects to be completed in FY2021/2022, which brings the total project costs to \$240,000.

Discussion took place regarding salary and benefit decisions before a decision on projects is finalized for the Parks Fund for the FY2021/2022 budget year. February 22, 2021 Work Session will be a discussion regarding salaries.

**City of St. Ann/Tiemeyer Park**

City of St. Ann is doing a two-phase study of the Pool Complex at Tiemeyer Park regarding renovation, configuration, and programming. St. Ann plans to apply for Planning Grants for both phases. The City of Overland has been invited to partner in the second phase of the project. City staff was directed to explore options with the City of St. Ann for this project.

AN ORDINANCE BY THE CITY COUNCIL OF THE CITY OF OVERLAND, MISSOURI, AMENDING SECTION 130.430 COURT COSTS AND FEES, BY THE ADDITION OF A SURCHARGE FOR SHELTERS FOR BATTERED PERSONS

NOW THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF OVERLAND, ST. LOUIS, COUNTY, MISSOURI, AS FOLLOWS:

**Section 1:** That Section 140.430 “Court Costs and Fees” is hereby amended by the addition of the following:

11. A surcharge in the sum of two dollars (\$2.00) authorized by Section 488.607, RSMo. for the purpose of providing operating expenses for shelters for battered persons, as defined in Sections 455.200 to 455.230, RSMo. Such cost shall be collected by the Clerk of the Court and disbursed by the City to such shelters that meet the requirements and qualifications of Sections 455.200 to 455.230, RSMo.

**Section 2:** All other existing provisions as contained in the Overland Municipal Code, shall remain in full force and effect without change.

**Section 3:** This ordinance shall be in full force and effect after its passage and approval according to law.
