Ordinance No. 2018-

AN ORDINANCE AMENDING TITLE III, TRAFFIC CODE, CHAPTER 300, SCHEDULE V, OF THE CODE OF ORDINANCES OF THE CITY OF OVERLAND, MISSOURI, BY THE DELETION AND THE ADDITION OF CERTAIN PROVISIONS TO THE PRESENT LIMITED AND PROHIBITED PARKING ON SPECIFIED STREETS AND TOWING PROVISIONS; LIMITED PARKING ON BURNS AVENUE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF OVERLAND, ST. LOUIS COUNTY, MISSOURI, AS FOLLOWS:

**Section 1:** That Title III, Chapter 300, Schedule V Limited and Prohibited Parking on Specified Streets and Towing Provisions, is hereby amended by addition of the following:

Burns Avenue, east side, beginning at the intersection of Trescott Avenue and Burns Avenue, to a point, Two Hundred and Ten Feet (210') south, no parking at any time.

**Section 2:** That said Chapter 300 in all of its other provisions and as herein amended shall remain in full force and effect.

**Section 3:** This ordinance shall be in full force and effect from and after its passage and approval according to law.
